# InFIRE Executive Committee meeting minutes, New Westminster, Vancouver, Sunday, 13 May 2007

The Executive Committee meeting began at 10am at the Executive Plaza Hotel, Coquitlam.

InfIRE will also cover the bus tour, speaker for the paddleboat cruise, speaker gifts and the opening reception at the hotel at 6.30pm this evening.

### **General Business**

Sue Marsh will become the next chair of inFIRE.

Next conference venues: 2008 hosted by Safety Engineering Laboratories in Detroit (Laura Logan). 2009 may be hosted by New Zealand Fire Service.

Discussion on ideas for attracting new attendees to the conference. Susan Walker spoke about sending out blast emails that had been graphically designed.

Registration fees are waived for the next inFIRE conference if you hosted a inFIRE conference. It was suggested to waive registration fees for first time attendees to encourage greater member participation. Discussion on the eligibility of this reduction – length of membership, organization had not previously attended. Diana Robison asked if we could do more for those who have not previously attended. Ask them what do they want from the workshop and inFIRE in general. Other suggestions such as having some presentations on video.

The format of proceedings was raised. Most speakers do not have written papers anymore. Can load up abstracts, biography and PowerPoint presentations. Also can include the daily note taking – try and include these notes within a month of the conference, so by 1 July 2007.
